It is designed to save clubs time, effort and money and provide enhanced cover and services for the netball community.

### Coverage

This Programme provides coverage 365 days of the year with an annual renewal date of 1st November.

### What’s Covered

In general, all netball activities are covered. This includes matches, training, functions, meetings and the like (anywhere in Australia). The Programme provides competitively broad protection across the following areas:
